

HYPERBOLICITY AND MODEL-COMPLETE FIELDS

ABSTRACT. We study model-complete fields that avoid a given quasi-project variety V . There is a close connection between hyperbolicity of V and the existence of the model companion for the theory of characteristic-zero fields avoiding rational points on V . This gives a model theoretic notion of hyperbolicity that we call *excludability*.

In particular, we show that if V is a Brody hyperbolic projective variety over \mathbb{Q} with $V(\mathbb{Q}) = \emptyset$, then the model companion, called VXF , exists. We also study some model-theoretic properties of VXF . This extends the results for curves by Will Johnson and the second author.

1. INTRODUCTION

As suggested by Artin, maximal subfields of an algebraic closed field avoiding a given set of points exhibit interesting properties, see [Qui62, McC67, EV83, EV82, GM80]. Similarly, one could ask about ‘maximal’ fields avoiding points in certain varieties. More precisely, let \tilde{V} be a smooth projective variety over a characteristic zero field k_0 with an open subset $V \subset \tilde{V}$ such that $V(k_0) = \emptyset$. Let T_V be the theory of fields extending k_0 that do not have points in V . A field $k \models T_V$ can be thought of as ‘maximal’, if it is *existentially closed*, which means that whenever X is a quasi-projective variety over k with $X(l) \neq \emptyset$ for some $k \subset l \models T_V$, then $X(k) \neq \emptyset$. Equivalently, a field k extending k_0 with $V(k) = \emptyset$ is existentially closed, if and only if the following conditions hold:

- (I_V) if l/k is any proper finite extension, then $V(l) \neq \emptyset$;
- (II_V) for any geometrically integral variety X/k , either there is a non-constant rational map $f : X \dashrightarrow V_k$ over k or $X(k)$ is Zariski dense in X .

We present an algebro-geometric proof of this equivalence in Section 2.

If the class of existentially closed models of T_V can be axiomatized by first-order formulas we say that T_V has a *model companion* and the model companion of T_V is the set of such axioms.

In [JY23a] the authors proved that if V is a curve C of genus greater or equal two, then the model companion exists.

Theorem 1.1. [JY23a, Theorem 2.1] *The theory T_C has a model companion CXF .*

The theories CXF provide interesting examples of classes of non-large fields. Recall that a field k is *large* if for any smooth curve D over k with $D(k) \neq \emptyset$, the set $D(k)$ is Zariski dense in D . Largeness is a tameness notion introduced by Pop to study regular inverse Galois problems [Pop96].

It has long been believed that the concept of largeness holds significance in model theory of fields. Specifically, it is believed that largeness plays a crucial role in simplifying conjectures concerning model theory of fields. For instance, Koenigsmann provided a straightforward

proof of the Podewski conjecture for large fields of arbitrary characteristic, a conjecture only known to be true in characteristic p [Wag00].

The relationship between largeness and model-theoretic tameness was extensively investigated in [JTWY24] through the introduction of the étale open topology. As a notable application, the paper resolved the stable fields conjecture for large fields. Subsequently, these methodologies were extended to encompass large simple fields in [PW23]. Further exploration of the étale open topology was conducted in [WY23, JWY23, DWY22], revealing a uniform approach for studying the structure of definable sets within large fields. Notably, this approach encompasses essentially all previously known examples of model-theoretically tame fields.

In [JY23a], CXF 's were introduced as the very first examples of non-large fields whose logical theories remain tame, answering questions by Koenigsmann and Macintyre concerning largeness, model-complete fields, and their Galois groups. Moreover, CXF 's exhibit intriguing combinations of properties, notably:

- (1) Model-theoretically, they are $NSOP_4$ and TP_2 .
- (2) Some models of CXF give rise to the first known examples of non-large, Hilbertian fields with a decidable theory.
- (3) The decidability of the partial theory CXF is equivalent to the effective Mordell conjecture for C .

The properties exhibited by CXF 's suggest that the precise relationship between largeness and logical tameness is more subtle than initially anticipated, warranting further investigation and attention.

To delve deeper into the relationship between largeness and logical tameness, a promising way is to construct and examine new examples. For instance, in [JY23a, Section 8], the authors pose a question regarding the possible extension of their findings to higher-dimensional varieties V (where $V(k_0) = \emptyset$) as opposed to a curve C . More precisely:

Question 1.2. What conditions on a quasi-projective variety V over k_0 ensure that the theory T_V of fields extending k with no points in V has a model companion?

Equivalently, one can form it in the following way:

Question 1.3. What conditions on a quasi-projective variety V over k_0 ensure that axioms:

- (I_V) if l/k is any proper finite extension, then $V(l) \neq \emptyset$;
- (II_V) for any geometrically integral variety X/k , either there is a non-constant rational map $f : X \dashrightarrow V_k$ over k or $X(k)$ is Zariski dense in X ;

are first-order conditions on a field k extending k_0 ?

We say V is *excludable* if the above question has a positive answer and denote the resulting model companion by VXF . Note that the axiom (I_V) is always first-order, see Remark 2.14. In this paper we provide many examples of higher dimensional excludable varieties and study properties of VXF . More precisely, we find a generalization of the condition “genus bigger or equal two” for a curve. This leads to the following theorem.

Main Theorem (Theorem 6.5). *Let \tilde{V} be a geometrically integral, geometrically pure, projective variety over k_0 . Let $V_0 \subset \tilde{V}$ be a closed subscheme such that \tilde{V} is geometrically bounded modulo V_0 . Let $V = \tilde{V} \setminus V_0$ and assume that $V(k_0) = \emptyset$. Then V is excludable.*

In the case $V_0 = \emptyset$, the assumptions of this theorem are satisfied, if for example $k_0 = \mathbb{Q}$ and $V(\mathbb{C})$ is Brody hyperbolic. Also, using [BD18] and [Fal91] together with the above, one gets that a ‘random enough’ subvariety of an abelian variety has an excludable open set.

Corollary 1.4 (Corollary 6.7). *Let A be an abelian variety over k_0 with an ample line bundle $\mathcal{O}_A(1)$. Let \tilde{V} be a sufficiently general intersection of at least half $\dim A$ many high enough powers of $\mathcal{O}_A(1)$ defined over k_0 . Then $\tilde{V}(k_0)$ is not Zariski dense in \tilde{V} and if $V \subset \tilde{V}$ is any open subscheme such that $V(k_0) = \emptyset$, then V is excludable.*

Let us elaborate on the conditions on the pair $V_0 \subset \tilde{V}$ appearing in the statement of Theorem 1. Fix a field k and a pair of varieties $X_0 \subset X$ over k with X projective and X_0 a closed subscheme. We say that:

- X is pure, if for every smooth variety T over k any rational map $T \dashrightarrow X$ extends to a regular map to X .
- X is bounded modulo X_0 , if for every normal projective variety Y over k , the scheme $\underline{\mathrm{Hom}}_k(Y, X) \setminus \underline{\mathrm{Hom}}_k(Y, X_0)$ is of finite type over k .
- X is indecomposable (over k), if for any integral, smooth, projective varieties X_1, X_2 over k , any map $X_1 \times X_2 \rightarrow X$ factors through X_1 or X_2 .

In the case where k is not algebraically closed, we add ‘geometrically’ to any of these properties, if it holds after base-changing to the algebraic closure. For details on pureness, boundedness modulo a subvariety and other notions of hyperbolicity, see Section 5 and [vBJK24], [Jav20]. The notion of indecomposability is introduced to capture the property of all non-constant maps to X being rigid. We need it to study properties of VXF for many examples of V , in particular we make use out of the following proposition.

Proposition 1.5 (Proposition 4.13). *Let X be a projective variety over k_0 . If X is geometrically indecomposable, then X_l is indecomposable over l for any field extension $k_0 \subset l$. Moreover, X is geometrically indecomposable, if and only if X_l is.*

It allows us to prove Lemma 7.2 which in turn proves the proposition below. Let us highlight that once VXF is known to exist as a first-order theory, its model-theoretic analysis more or less follows from [JY23a]. The real work of this paper in comparison to [JY23a] lies in (i) identifying the analogue of genus > 1 in higher dimensions, and (most importantly) (ii) proving that the model-companion VXF exists under this assumption.

Proposition 1.6 (Proposition 7.4). *Let V be a quasi-projective excludable variety over k_0 . Assume that V has a projective compactification \tilde{V} which is geometrically integral and geometrically indecomposable. Then the theory VXF has the following properties.*

- (1) Let $l_1, l_2 \models \text{VXF}$. Then $l_1 \equiv l_2$ if and only if $\text{Abs}_{k_0}(l_1) \simeq \text{Abs}_{k_0}(l_2)$ as k_0 -fields. Moreover, for any algebraic extension $k_0 \subset k$ avoiding V , there is a model $l \models \text{VXF}$ such that $\text{Abs}_{k_0}(l) = k$.
- (2) VXF has quantifier elimination if we expand by the predicates

$$\text{Sol}_n(x_0, \dots, x_n) \leftrightarrow \exists y x_0 + yx_1 + \dots + y^n x_n = 0.$$

- (3) Model-theoretic and field-theoretic (relative) algebraic closure coincide in models of VXF. In particular, models of VXF are algebraically bounded over k_0 .
- (4) VXF is a geometric theory, i.e., acl satisfies the exchange property and \exists^∞ is uniformly eliminated.

- (5) Every proper finite extension of models of VXF is a Hilbertian PAC field.
- (6) Models of VXF are Hilbertian. Moreover, the absolute Galois group is ω -free.
- (7) In the axiomatization of VXF one can in fact skip the axiom (I_V) . In other words, fields k that avoid V and satisfy (II_V) are models of VXF.
- (8) Model-theoretically, VXF is NSOP₄ and TP₂.

It is worth mentioning that in the context of Theorem 1.4 the assumptions of Theorem 1.6 are satisfied because of the Brotbek and Darondeau theorem [BD18].

Before we conclude the introduction, let us briefly discuss the relationship between excludability and other notions of hyperbolicity. In the main theorem, we prove that boundedness implies excludability. There is a weaker property than boundedness, called grouplessness that is conjectured to be equivalent to boundedness (for details, see Remark 5.3). If excludability implies grouplessness, it would give a new intermediate property in the list of conjecturally equivalent hyperbolicity properties of a variety [Jav20, Conjecture 12.2]. Thus, we ask the following.

Question 1.7. Is there a geometrically integral, smooth projective variety V over k_0 (with no rational points in k_0) that is excludable, but not groupless?

The article is organized as follows. In Section 2 we present some definitions from logic in algebro-geometric flavour. In Sections 3 and 4 we survey some results from intersection theory and the theory of Hilbert schemes respectively. In the latter section we prove Proposition 4.13. In Section 5 we describe relations between various notions of hyperbolicity/rigidity in algebraic geometry. In Sections 6 and 7 we prove the main theorems of the paper. At last, in Section 8, we provide an example in characteristic p , of a curve C such that T_C does not admit a model companion. This is the content of Proposition 8.2. We also pose some questions about possible further directions of studies.

2. EXISTENTIAL CLOSEDNESS AND MODEL COMPANION

In this section we present some definitions coming from logic in an algebro-geometric flavour. The results follow easily by generalising [JY23a, Section 1], however, we decided to include them here for the convenience of the reader. Fix a characteristic zero field k_0 . We work with the language consisting of plus, minus, multiplication, and constants from k_0 . Let V be a quasi-projective variety over k_0 .

Definition 2.1. Let T_V be a theory in the above-introduced language such that models of T_V are fields k containing k_0 with $V(k) = \emptyset$. We denote it by $k \models T_V$.

This is a first-order theory, which means that it can be written as a set of axioms being first-order sentences. Recall that first-order means that one can quantify over elements, but not over subsets. For example, if $V \subset \mathbb{P}^N$ is the intersection of the zero set of homogeneous polynomials f_1, \dots, f_n and the non-vanishing locus of homogeneous polynomials g_1, \dots, g_m , then T_V can be given by the following axioms.

- Axioms for relations in k_0 : if for example $a + b = c$ in k_0 , then we put here the corresponding relation among constants from k_0 .
- Field axioms: for example $(\forall x)(x + 0 = 0 + x = x)$ or $(\forall x)(x \neq 0 \rightarrow (\exists y)(x \cdot y = 1))$.
- Excluding V axiom: $\neg(\exists x = (x_0, \dots, x_N))(x \neq 0 \wedge \bigwedge_{i=1}^n f_i(x) = 0 \wedge \bigvee_{j=1}^m g_j(x) \neq 0)$.

Note that this theory is consistent (i.e., has a model) if and only if $V(k_0)$ is already empty. Moreover, it is clear that this theory only depends on the reduction of V . We now present the definition of existential closedness in an algebro-geometric fashion.

Definition 2.2. If k is a model of T_V , then k is called *existentially closed* if for every quasi-projective variety X over k , if there exists an extension $k \subset l$ within models of T_V such that $X(l) \neq \emptyset$ (i.e., X has a $\text{Spec}(l)$ -point over $\text{Spec}(k)$), then $X(k) \neq \emptyset$.

Remark 2.3. If an embedding $k \subset l$ of fields satisfies the condition from the above definition, for every quasi-projective variety X over k , then we say that k is existentially closed in l .

Example 2.4. If V is the empty variety, then by Nullstellensatz, a field is existentially closed if and only if it is algebraically closed. Thus, one can think of existentially closed models of T_V as models of T_V that are as close to algebraically closed fields as the condition of not having points in V allows.

If T_V is consistent, existentially closed models exist, but the question is when do they also form an elementary class.

Definition 2.5. We say that T_V has a *model companion* if the class of existentially closed models of T_V is *elementary*, i.e., if there exists a set T of first-order axioms such that existentially closed models of T_V are exactly the models of T_V satisfying the axioms from T . Note that if such T exists, it is unique up to logical consequences.

Example 2.6. If V is the empty variety, then as mentioned in Example 2.4, existentially closed models of T_V are just algebraically closed fields and those can be axiomatized by the following countable list of axioms:

$$\{(\forall y_0, \dots, y_{n-1})(\exists x)(x^n + y_{n-1}x^{n-1} + \dots + y_1x + y_0 = 0) : n \in \mathbb{N}\}.$$

Definition 2.7. Let V be a quasi-projective variety over k_0 . We call it *excludable* if the theory T_V has a model companion. Then we denote by VXF the theory axiomatizing existentially closed models of T_V .

Assume from now on that V is a geometrically integral positive-dimensional variety with $V(k_0) = \emptyset$. In the rest of this section we focus on giving conditions for being an existentially closed model of T_V .

Lemma 2.8. *If k is existentially closed in all finitely generated extensions $k \subset l$ within T_V , then k is an existentially closed model of T_V .*

Proof. This follows from the fact that a subfield of a model of T_V (containing k_0) is a model of T_V . \square

Lemma 2.9. *If k is an existentially closed model of T_V and $k \subset l$ is a proper finite extension of fields, then $V(l) \neq \emptyset$.*

Proof. If $V(l) = \emptyset$, then $l \models T_V$. Let $a \in l \setminus k$ be an element with a minimal polynomial $P(x) \in k[x]$. From the definition of existential closedness, we then get that the equation $P(x) = 0$ has a solution in k , which gives us a contradiction. \square

The next lemma is well-known, but we include it for the sake of completeness.

Lemma 2.10. *Let X be an integral variety over k . Then X is geometrically integral if and only if $k \subset k(X)$ is regular, i.e., there is no proper finite extension $k \subset l$ with l contained in $k(X)$.*

Proof. Note that by [Sta24, Lemma 020I] the scheme X is geometrically integral if and only if it is geometrically irreducible, as we assume characteristic zero. By [Sta24, Lemma 054Q] this is equivalent to the field $k(X)$ being geometrically irreducible over k . By [Sta24, Lemma 038I] this is equivalent to $k(X) \otimes_k k'$ being irreducible for every finite extension k'/k . But by the primitive element theorem, every finite extension of k is of the form $k[x]/(P)$ for some irreducible polynomial $P \in k[x]$. Thus the geometric integrability of X is equivalent to the fact that for an irreducible $P \in k[x]$, it is still irreducible as an element of $k(X)[x]$. This is equivalent to the extension $k \subset k(X)$ being regular. □

Remark 2.11. Let X be an integral variety over k . Then the set of rational maps $X \dashrightarrow V_k$ over k can be naturally identified with the set $V_k(k(X))$ (morphisms in Sch_k). Under this identification $V_k(k)$ corresponds to constant maps (factoring through $\text{Spec}(k)$) from X to V_k .

Lemma 2.12. *Let X be an integral variety over k . Then the embedding $k \subset k(X)$ is existentially closed, if and only if $X(k)$ is Zariski dense in X .*

Proof. First, assume that $k \subset k(X)$ is existentially closed. If $U \subset X$ is a Zariski open non-empty subset, then $U(k(X)) \neq \emptyset$, so by existential closedness, we get that $U(k) \neq \emptyset$. Hence $X(k)$ is Zariski dense in X .

Second, assume that $X(k)$ is Zariski dense in X . Let Y be a quasi-projective variety over k and assume that $Y(k(X))$ is non-empty. By Remark 2.11 we conclude that there is a rational map $f : X \dashrightarrow Y$ over k . Let $U \subset X$ be an open subset such that $f : U \rightarrow Y$ is a regular map. By assumption $U(k)$ is non-empty, so we get that Y has a k -point, which finishes the proof. □

Corollary 2.13. *Let k be a model of T_V . It is existentially closed if and only if the following conditions hold:*

(I_V) *If l/k is any proper finite extension, then $V(l) \neq \emptyset$.*

(II_V) *For any geometrically integral variety X/k , either there is a non-constant rational map $f : X \dashrightarrow V_k$ over k or $X(k)$ is Zariski dense in X .*

Proof. Assume first that k is existentially closed. Point (I_V) is Lemma 2.9. Fix a geometrically integral variety X/k and assume there is no non-constant rational map $f : X \dashrightarrow V_k$ over k . By Remark 2.11 we have $V_k(k(X)) = V_k(k) = \emptyset$. Thus $k(X)$ is a model of T_V . By Lemma 2.12 we are done.

On the other hand, assume that k satisfies (I_V), (II_V). By Lemma 2.8 it is enough to check that k is existentially closed in every finitely generated extension $k \subset F$ with $F \models T_V$. By (I_V) there is no proper finite extension $k \subset l$ with l contained in F . Pick an integral variety X over k with $k(X) = F$ over k . By Lemma 2.10 we know that X is geometrically integral and by Remark 2.11 there is no rational map $X \dashrightarrow V_k$ over k . Hence, $X(k)$ is Zariski dense in X by (II_V). By Lemma 2.12 we are done. □

Remark 2.14. The condition (I_V) above is a first-order condition on a field k . Indeed, one can present it as an axiom schema of the form “for all degree n extensions l/k there is a point in $V(l)$ ” for all natural n . These are first-order, because a degree n extension of l/k

can be encoded by a tuple of elements $\alpha_{ijk} \in k$ such that if $\{e_i\}_{i=1,\dots,n}$ is a basis of l over k , then $e_i \cdot e_j = \sum_k \alpha_{ijk} e_k$.

The condition (II_V) is a priori not a first-order condition on k . The main result of this paper is that some hyperbolicity assumptions on V actually make it first-order.

3. INTERSECTION THEORY

In this section we present some properties of the intersection product in algebraic geometry. We work over an algebraically closed field k of characteristic zero. For a more thorough introduction to intersection theory we refer the reader to [Ful98] and [Vak24, Chapter 21].

Definition 3.1. For an irreducible projective variety X over k we denote by $A_i(X)$ the i 'th *Chow group* of X consisting of cycles of dimension i (i.e., integer combinations of irreducible subvarieties of X of dimension i) up to rational equivalence. In particular $A_{d-1}(X)$ is the group of Weil divisors on X modulo rational equivalence, if $d = \dim X$. If $\alpha \in A_e(X)$ and L_1, \dots, L_e are line bundles on X , then we can form an intersection number denoted by

$$\int_{\alpha} c_1(L_1) \cdot \dots \cdot c_1(L_e) \in \mathbb{Z}.$$

If $\alpha = [Z]$ is a class of a subvariety $Z \subset X$ we denote this also by

$$\int_Z c_1(L_1) \cdot \dots \cdot c_1(L_e).$$

These intersection numbers do not depend on the order of L_i 's and are multilinear with respect to the tensor product of line bundles.

Remark 3.2. We will need a few operations/properties from intersection theory. We describe them below.

- (1) Let s_1, \dots, s_p be global sections of L_1, \dots, L_p respectively, and assume that their zero sets restricted to Z form a complete intersection W . Recall that this means that s_i is not a zero divisor locally on $Z \cap \operatorname{div}(s_1) \cap \dots \cap \operatorname{div}(s_{i-1})$ for $i \leq p$ and $W = Z \cap \bigcap_{i \leq p} \operatorname{div}(s_i)$. Then

$$\int_Z c_1(L_1) \cdot \dots \cdot c_1(L_e) = \int_W c_1(L_{p+1}) \cdot \dots \cdot c_1(L_e).$$

Moreover, if $p = e$, then W is just a disjoint sum of copies of $\operatorname{Spec}(k)$ and the number of copies is exactly the intersection number.

- (2) For a morphism $f : X \rightarrow Y$ between proper varieties, there is a family of *pushforward* maps $f_* : A_e(X) \rightarrow A_e(Y)$ for all e . For an irreducible subvariety $V \subset X$ we have

$$f_*[V] = \deg(V/f(V))[f(V)],$$

where by $[-]$ we denote the class of a subvariety in the Chow group, and $\deg(V/f(V))$ is the degree of the extension of the field of rational functions on $f(V)$ by the field of rational functions on V . If $\deg(V/f(V))$ is infinite, we put $f_*[V] = 0$.

- (3) For a morphism $f : X \rightarrow Y$ between schemes, if L is a line bundle on Y , we can pull it back on X and we denote the *pullback* by f^*L . If moreover X and Y are proper irreducible varieties and $\alpha \in A_e(X)$, then the *projection formula* holds:

$$\int_{\alpha} c_1(f^*L_1) \cdot \dots \cdot c_1(f^*L_e) = \int_{f_*\alpha} c_1(L_1) \cdot \dots \cdot c_1(L_e).$$

- (4) The intersection number $\int_Z c_1(L_1) \cdot \dots \cdot c_1(L_e)$ can be defined in terms of Euler characteristics of tensor products of duals of L_i 's restricted to Z . In particular, if $\mathcal{X} \rightarrow S$ is a morphism, $\mathcal{L}_1, \dots, \mathcal{L}_e$ are line bundles on \mathcal{X} and we are given a subscheme $\mathcal{Z} \subset \mathcal{X}$ flat over S (for the definition of flatness see Remark 4.2) with relative dimension e , then for any field l and any $s \in S(l)$ the numbers

$$\int_{\mathcal{Z}_s} c_1((\mathcal{L}_1)_s) \cdot \dots \cdot c_1((\mathcal{L}_e)_s)$$

are constant. This is because Euler characteristic is constant in flat families.

Remark 3.3. If X is smooth, then one usually writes $A^i(X) := A_{d-i}(X)$ and $A^*(X) := \bigoplus_{i=0}^d A^i(X)$ has a structure of a graded ring.

Let X be a projective variety over k . We present the definition of the Néron–Severi group of X .

Definition 3.4. If L is a line bundle on X and C is an 1-cycle in X , then we define $L.C := \int_C c_1(L)$. See [Vak24, Chapter 21] for the definition in the non-smooth case. This operation gives a pairing

$$\text{Pic}(X) \times A_1(X) \rightarrow \mathbb{Z},$$

where $\text{Pic}(X)$ is the set of isomorphism classes of line bundles on X . Two line bundles $L, M \in \text{Pic}(X)$ are *numerically equivalent* (denoted $L \equiv M$) if for all $\gamma \in A_1(X)$ we have $L.\gamma = M.\gamma$. Similarly, two 1-cycles $\gamma, \delta \in A_1(X)$ are numerically equivalent (denoted $\gamma \equiv \delta$) if for all line bundles $L \in \text{Pic}(X)$ we have $L.\gamma = L.\delta$. The *Néron–Severi group* of X is the group

$$\text{NS}(X) := \text{Pic}(X) / \equiv.$$

It is a finitely generated abelian group and we use the notation $N^1(X) := \text{NS}(X) \otimes_{\mathbb{Z}} \mathbb{R}$. Moreover, we write $N_1(X) := (A_1(X) / \equiv) \otimes_{\mathbb{Z}} \mathbb{R}$ and intersecting line bundles and 1-cycles yields a perfect pairing

$$N^1(X) \times N_1(X) \rightarrow \mathbb{R}.$$

Below we introduce some important cones in $N^1(X), N_1(X)$.

- Definition 3.5.**
- (1) The *effective cone* of curves is the closed convex cone in $N_1(X)$ spanned by classes of irreducible curves $C \subset X$.
 - (2) The *nef cone* is the closed convex cone in $N^1(X)$ consisting of classes $\alpha \in N^1(X)$ such that for all irreducible curves $C \subset X$ we have $\alpha.[C] \geq 0$. In other words, it is the dual cone to the effective cone of curves.
 - (3) The *ample cone* is the interior of the nef cone in $N^1(X)$. Equivalently, it is the open cone generated by the classes of ample line bundles. Recall that $L \in \text{Pic}(X)$ is ample, if there exists a positive tensor power $L^{\otimes n}$ of L which is very ample, i.e., such that the mapping

$$X \rightarrow \mathbb{P}^N$$

$$x \mapsto [s_0(x) : s_1(x) : \dots : s_N(x)],$$

defines a closed embedding, where s_0, \dots, s_N is some basis of $H^0(X, L^{\otimes n})$.

Remark 3.6. Assume that d is the dimension of X and let L, M be nef line bundles on X . For $i = 0, \dots, d$ define $s_i = \int_X c_1(L)^i c_1(M)^{d-i}$. Then the Khovanskii-Teissier inequalities assert that the sequence s_i is log-concave, i.e.,

$$s_i^2 \geq s_{i-1} s_{i+1},$$

for $i = 1, \dots, d-1$. For a proof, see [Laz04a, Example 1.6.4]. Note that it follows from the projection formula, that a pullback of a nef line bundle is also nef, hence one can use these inequalities also in such context.

4. HILBERT SCHEMES

In this section we introduce Hilbert schemes and mention a few results needed later in the text. See also [FGI⁺05] for a detailed introduction and [MPZ23, Section 6] for an introduction avoiding the language of schemes. Let S be a scheme which will serve as our base-scheme. We denote by k an arbitrary field. If X is a projective variety over k , then the Hilbert scheme $\underline{\text{Hilb}}_k(X)$ is a countable sum of projective schemes over k such that k -points of $\underline{\text{Hilb}}_k(X)$ correspond to closed subschemes $Z \subset X$. For a family of varieties $\mathcal{X} \rightarrow S$ indexed by a variety S one can put the Hilbert schemes of the fibers into one scheme over S . We introduce it below.

Definition 4.1. Let $\mathcal{X} \rightarrow S$ be a flat projective morphism with a relatively ample line bundle $\mathcal{O}(1)$ on \mathcal{X} . The *Hilbert scheme* of \mathcal{X} over S denoted by $\underline{\text{Hilb}}_S(\mathcal{X})$ is a scheme over S which is characterised by the following property. For every $T \in \text{Sch}_S$ morphisms from T to $\underline{\text{Hilb}}_S(\mathcal{X})$ can be described as

$$\underline{\text{Hilb}}_S(\mathcal{X})(T) = \{Z \subset \mathcal{X}_T : Z \text{ is a closed subscheme of } \mathcal{X}_T \text{ flat over } T\}.$$

There exists a disjoint decomposition

$$\underline{\text{Hilb}}_S(\mathcal{X}) = \bigcup_P \underline{\text{Hilb}}_S^P(\mathcal{X}),$$

where P varies among polynomials in $\mathbb{Q}[t]$, such that each $\underline{\text{Hilb}}_S^P(\mathcal{X})$ is a projective scheme over S . Moreover, for a field k and $s \in S(k)$, the k -points of $\underline{\text{Hilb}}_S^P(\mathcal{X})$ over s are in a natural bijection with

$$\{Z \subset \mathcal{X}_s : Z \text{ is a closed subscheme of } \mathcal{X}_s \text{ with the Hilbert polynomial } P\}.$$

We recall that the *Hilbert polynomial* of a closed subscheme $Z \subset \mathcal{X}_s$ (with respect to $\mathcal{O}(1)$) is the unique polynomial $P \in \mathbb{Q}[t]$ such that for natural numbers m big enough we have

$$P(m) = \dim_k H^0(Z, \mathcal{O}(m)|_Z),$$

or equivalently $P(m) = \chi(\mathcal{X}_s, \mathcal{I}_Z(m))$ for all natural m , with \mathcal{I}_Z being the ideal sheaf of Z in \mathcal{X}_s and χ being the Euler characteristic.

Remark 4.2. For the definition of flatness we refer to [Sta24]. A projective morphism between varieties over k is flat if and only if the Hilbert polynomials of all geometric fibers are the same.

Remark 4.3. Fix the notation from the above definition. We list here some useful properties of Hilbert schemes. The first three properties follow from the definition of functor defying Hilbert schemes, see e.g. [FGI⁺05] for details. The last property is [Ful98, Example 2.5.2] or [Sta24, Proposition 0BJ8].

- If \mathcal{Y} is a closed subscheme of \mathcal{X} flat over S , then there is a natural closed immersion $\underline{\text{Hilb}}_S(\mathcal{Y}) \subset \underline{\text{Hilb}}_S(\mathcal{X})$.
- For $s \in S(k)$ the base-change of $\underline{\text{Hilb}}_S(\mathcal{X})$ via the map $s : \text{Spec}(k) \rightarrow S$ is isomorphic to $\underline{\text{Hilb}}_k(\mathcal{X}_s)$.
- The identity morphism $\underline{\text{Hilb}}_S(\mathcal{X}) \rightarrow \underline{\text{Hilb}}_S(\mathcal{X})$ corresponds to a canonical closed subscheme $\mathcal{U} \subset \mathcal{X} \times_S \underline{\text{Hilb}}_S(\mathcal{X})$ flat over $\underline{\text{Hilb}}_S(\mathcal{X})$, which we refer to as the *universal family* of $\underline{\text{Hilb}}_S(\mathcal{X})$. Consider $f : \text{Spec}(k) \rightarrow \underline{\text{Hilb}}_S(\mathcal{X})$ corresponding to a closed subscheme $Z \subset \mathcal{X}_s$ with $s \in S(k)$ being the composition of f and the projection to S . If we form the Cartesian diagram

$$\begin{array}{ccc}
\mathcal{U}_s & \longrightarrow & \mathcal{U} \\
\downarrow & & \downarrow \\
\mathcal{X}_s & \longrightarrow & \mathcal{X} \times_S \underline{\text{Hilb}}_S(\mathcal{X}) \\
\downarrow & & \downarrow \\
\text{Spec}(k) & \xrightarrow{f} & \underline{\text{Hilb}}_S(\mathcal{X})
\end{array}$$

the subscheme Z will be exactly the image of \mathcal{U}_s in \mathcal{X}_s (the ideal sheaves will be the same).

- Let P be the Hilbert polynomial of $[Z] \in \underline{\text{Hilb}}_k(X)(k)$ for a projective variety X over algebraically an closed field k with respect to an ample line bundle L on X . Then the degree of P is $d := \dim Z$ and the leading coefficient of P can be calculated using intersection theory as $\frac{1}{d!} \int_Z c_1(L)^d$.

Remark 4.4. Not every polynomial $P \in \mathbb{Q}[t]$ can be obtained as the Hilbert polynomial of some closed subscheme $X \subset \mathbb{P}_k^n$ with respect to $\mathcal{O}(1)$. By a theorem of Gotzmann [Got78] (see also the discussion in [Laz04a, Section 1.8.C, Theorem 1.8.35]) there are unique integers

$$a_1 \geq a_2 \geq \cdots \geq a_s \geq 0,$$

such that $P(m)$ can be expressed in the form

$$P(m) = \binom{m + a_1}{a_1} + \binom{m + a_2 - 1}{a_2} + \cdots + \binom{m + a_s - (s - 1)}{a_s}.$$

In particular, there are only finitely many possibilities for such P of a fixed degree and bounded leading coefficient.

Using Hilbert schemes one can build a countable family of schemes parametrising all projective schemes. We need the following variant.

Proposition 4.5. *There is a countable family of smooth projective morphisms between finite type schemes over k*

$$\{\mathcal{X}_i \rightarrow S_i\}_{i \in I}$$

together with closed subschemes $Z_i \subset \mathcal{X}_i$ such that S_i are quasi-projective over k and for every smooth, geometrically integral variety $X \subset \mathbb{P}_l^n$ together with a closed subscheme $Z \subset X$ over any field l extending k , there is an $i \in I$ and $s \in S_i(l)$ such that the inclusions $Z \subset X, (Z_i)_s \subset (\mathcal{X}_i)_s$ are isomorphic over l .

Proof. Let H_0 be a connected component of $\underline{\text{Hilb}}_k(\mathbb{P}_k^n)$ and denote by $U \subset \mathbb{P}_k^n \times_k H_0$ the intersection of the universal family of $\underline{\text{Hilb}}_k(\mathbb{P}_k^n)$ with $\mathbb{P}_k^n \times_k H_0$. Note that $U \rightarrow H_0$ is a flat morphism between projective varieties over k .

Let $H_1 = \underline{\text{Hilb}}_{H_0}(U)$ and denote by $\mathcal{Z} \subset U \times_{H_0} \underline{\text{Hilb}}_{H_0}(U)$ the universal family of $\underline{\text{Hilb}}_{H_0}(U)$. Let S_1 be a connected component of H_1 and let $\mathcal{X}_1 = U \times_{H_0} S_1$. Moreover, define \mathcal{Z}_1 to be the intersection of \mathcal{Z} with \mathcal{X}_1 .

Let $Z \subset X \subset \mathbb{P}_l^n$ be a given tuple of subschemes of \mathbb{P}_l^n over a field l extending k . Let $h = [X] \in \underline{\text{Hilb}}_k(\mathbb{P}_k^n)(l)$ be the corresponding point in the Hilbert scheme and assume that $h \in H_0(l)$. By the definition of the universal family U we then get that $U_h \subset \mathbb{P}_l^n$ is equal to X in the sense of Remark 4.3. Morphisms from $\text{Spec}(l)$ to H_1 over $h \in H_0(l)$ correspond to subschemes of $U_h = X$, so there is $s \in H_1(l)$ corresponding to $Z \subset X$. Assume that $s \in S_1(l)$. Then we get a pullback diagram

$$\begin{array}{ccc} Z & \longrightarrow & \mathcal{Z} \\ \downarrow & & \downarrow \\ X & \longrightarrow & \mathcal{X}_1 \\ \downarrow & & \downarrow \\ \text{Spec}(k) & \xrightarrow{s} & S_1 \end{array}$$

In this construction we made a choice of a connected component twice. By looking at all possible such choices, and then shrinking each component obtained S_1 by a (relatively) open subset over which fibers of $\mathcal{X}_1 \rightarrow S_1$ are smooth and geometrically integral (note that this is possible by generic smoothness, e.g. by [Sta24, Lemma 0C3K, Lemma 056V]), we get a countable family $\{\mathcal{X}_i \rightarrow S_i\}_{i \in I}$ that we were looking for. \square

Closely related to Hilbert schemes are Hom schemes. Intuitively, the point is that if we can form moduli of subsets of varieties, then we can also form moduli of morphisms between varieties, by looking at graphs of such morphisms. We give a functorial description below.

Definition 4.6. Let \mathcal{X}, \mathcal{Y} be two projective schemes over S with $\mathcal{X} \rightarrow S$ flat. There exists a scheme over S denoted by $\underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y})$ such that for any scheme $T \in \text{Sch}_S$ the set of morphisms from T to $\underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y})$ is naturally identified with

$$\underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y})(T) = \{\text{morphisms } \mathcal{X}_T \rightarrow \mathcal{Y}_T \text{ over } T\}.$$

We call this scheme the *Hom scheme* of morphisms from \mathcal{X} to \mathcal{Y} over S . There is an open embedding $\underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y}) \rightarrow \underline{\text{Hilb}}_S(\mathcal{X} \times_S \mathcal{Y})$ which on the level of functors $\text{Sch}_S \rightarrow \text{Set}$ is given by sending a morphism $f : \mathcal{X}_T \rightarrow \mathcal{Y}_T$ to its graph $\Gamma_f \subset \mathcal{X}_T \times_T \mathcal{Y}_T = (\mathcal{X} \times_S \mathcal{Y})_T$ (which is flat over T).

Again, the relative Hom scheme fits together the family of Hom schemes of morphisms between fibers of families \mathcal{X}, \mathcal{Y} . More precisely, if $s \in S(k)$, then the base-change of $\underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y})$ via s is the scheme $\underline{\text{Hom}}_k(\mathcal{X}_s, \mathcal{Y}_s)$ and its k -points correspond to maps $\mathcal{X}_s \rightarrow \mathcal{Y}_s$ over k .

Remark 4.7. If $\mathcal{Y}_0 \subset \mathcal{Y}$ is a closed subscheme, then there exists a natural closed immersion $\underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y}_0) \subset \underline{\text{Hom}}_S(\mathcal{X}, \mathcal{Y})$ of S -schemes. As a map of functors it sends $f : \mathcal{X}_T \rightarrow (\mathcal{Y}_0)_T$ to the composition of f with the embedding $(\mathcal{Y}_0)_T \subset \mathcal{Y}_T$.

Remark 4.8. Consider the morphism $\mathcal{Y} \rightarrow \underline{\mathrm{Hom}}_S(\mathcal{X}, \mathcal{Y})$ of S -schemes given by the map of functors

$$(T \xrightarrow{g} \mathcal{Y}) \mapsto (\mathcal{X}_T \xrightarrow{p_2} T \xrightarrow{(g, \mathrm{id})} \mathcal{Y}_T).$$

This map is a monomorphism and one can check that it satisfies the valuative criterion of properness. Thus it is a closed immersion. We will denote by $\underline{\mathrm{Hom}}_S^c(\mathcal{X}, \mathcal{Y})$ the corresponding closed subscheme of $\underline{\mathrm{Hom}}_S(\mathcal{X}, \mathcal{Y})$, and by $\underline{\mathrm{Hom}}_S^{\mathrm{nc}}(\mathcal{X}, \mathcal{Y})$ its complement.

To understand the structure of the constant and non-constant parts of the Hom scheme, one can use the following.

Lemma 4.9. [Vak24, 11.5.12. Rigidity Lemma] *Let X be a projective, geometrically integral variety over k with a k -point, and Y be an irreducible variety over k . Fix a morphism $f : X \times_k Y \rightarrow Z$. If $q \in Y$ (a scheme theoretic point) is such that f is constant on $X \times \{q\}$, then f factors through Y .*

Remark 4.10. Let X, Z be projective varieties over k with X geometrically integral. Consider the closed immersion $Z \simeq \underline{\mathrm{Hom}}_k^c(X, Z) \subset \underline{\mathrm{Hom}}_k(X, Z)$. In this case, its image is actually a connected component of $\underline{\mathrm{Hom}}_k(X, Z)$, as otherwise one could construct a map from an irreducible variety $Y \rightarrow \underline{\mathrm{Hom}}_k(X, Z)$ whose image intersects $\underline{\mathrm{Hom}}_k^c(X, Z)$, but this would contradict the rigidity lemma above, at least after passing to the algebraic closure of k . Note that we can pass freely to the algebraic closure, as

$$\underline{\mathrm{Hom}}_k(X, Z) \otimes_k \bar{k} \simeq \underline{\mathrm{Hom}}_{\bar{k}}(X_{\bar{k}}, Z_{\bar{k}}).$$

Using Hom schemes we study the following property.

Definition 4.11. We call a projective variety X (over k) *indecomposable* over k , if for any geometrically integral, smooth, projective varieties X_1, X_2 over k , any map $X_1 \times X_2 \rightarrow X$ factors through X_1 or X_2 . Moreover, for a variety over a non-necessarily algebraically closed field, we call it *geometrically indecomposable* if its base-change to the algebraic closure is indecomposable.

Lemma 4.12. *Let X_2, X be projective varieties over k with X_2 geometrically integral. Consider the following properties:*

- (1) *The scheme $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ is discrete.*
- (2) *For every geometrically integral, projective variety X_1 over k any map $X_1 \times_k X_2 \rightarrow X$ factors through a projection to X_1 or X_2 .*

Then (1) \implies (2) and if k is algebraically closed, also the other implication holds.

Proof. Note that by Remark 4.10, a non-constant map $X_1 \rightarrow \underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ corresponds exactly to a map $X_1 \times_k X_2 \rightarrow X$ over k not factoring through the projections to both X_1 and X_2 .

If X_1 is geometrically integral, then any map from X_1 to a discrete scheme over k factors through a morphism from $\mathrm{Spec}(k)$. Thus discreteness of $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ implies that any map $X_1 \rightarrow \underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ factors through a k -point of $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ which corresponds to the fact that any map $X_1 \times_k X_2 \rightarrow X$ factors through a projection to X_2 .

On the other hand, in the case k is algebraically closed, if $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ is not discrete, then there is an integral variety X_1 over k with a non-constant map $X_1 \rightarrow \underline{\mathrm{Hom}}_k^{\mathrm{nc}}(X_2, X)$ which contradicts (2). \square

Proposition 4.13. *Let X be a projective variety over k . If X is geometrically indecomposable, then X_l is indecomposable over l for any field extension $k \subset l$. Moreover, X is geometrically indecomposable if and only if X_l is.*

Proof. Let $\{\mathcal{X}_i \rightarrow S_i\}_{i \in I}$ be the set from Proposition 4.5. By Lemma 4.12 (and resolution of singularities), indecomposability of X is equivalent to the following condition: for every morphism $\mathcal{X}_i \rightarrow S_i$ from the above collection, if $\mathcal{X} \rightarrow S$ is its base-change to k , then the morphism $H := \underline{\text{Hom}}_S^{\text{nc}}(\mathcal{X}, X_S) \rightarrow S$ has discrete fibers over \bar{k} -points. Note that by choosing relatively ample line bundle on \mathcal{X} and an ample line bundle on X , the scheme $H \rightarrow S$ can be presented as a disjoint sum of quasi-projective components over S . Hence, $H \rightarrow S$ is locally quasi-finite, and one can use [Sta24, Lemma 06RT] to get that for any field extension $k \subset l$, the fibers over l -points of S are also discrete, which by Lemma 4.12 proves that X_l is indecomposable over l .

To see the moreover part of the proposition, we only need to see that if the fibers over \bar{l} -points of S of morphisms $H \rightarrow S$ are discrete, then also fibers over \bar{k} -points of S are discrete. This is clear as we can embed $\bar{k} \subset \bar{l}$. \square

5. RIGIDITY IN ALGEBRAIC GEOMETRY

In this section we present some results from algebraic geometry that one can use to find examples of varieties V for which the theory of fields without points in V has a model companion and some further nice properties. In the case of [JY23a] the variety $V = C$ is a genus ≥ 2 curve and this assumption is used to construct some uniformly definable sets (moduli) of rational functions from smooth varieties to C . Recall that the genus of a smooth curve C is the dimension of the space of global differential forms on C . In this section we consider some other positivity assumptions on the vector bundle Ω_V of differential forms on V . We outline how such assumptions imply existence of (moduli) spaces of rational functions from smooth varieties to V . We mostly follow [Laz04b, Chapter 6] and [JK20] in our presentation.

Let X be a smooth projective variety over an algebraically closed field k . If X is a curve, then the cotangent bundle is in fact a line bundle on X and it makes sense to ask whether it is ample. This is not the case in higher dimensions. Still, Hartshorne defined a notion of ampleness for vector bundles of arbitrary rank. For a vector bundle E on X , we denote by $\mathbb{P}(E)$ the projectivisation of E , i.e., the set of codimension one hyperplanes passing through zero in fibers of E over X .

Definition 5.1. A vector bundle E on X is ample, if the line bundle $\mathcal{O}_{\mathbb{P}(E)}(1)$ on $\mathbb{P}(E)$ is ample. Note that $\mathcal{O}_{\mathbb{P}(E)}(1)$ is always relatively ample over X .

For a smooth curve C its cotangent bundle is ample if and only if the genus of g is bigger than one. In higher dimensions ampleness of the cotangent bundle intuitively means that the variety is very rigid. To make this statement more precise we introduce some rigidity notions in algebraic geometry.

Definition 5.2. Let X be a smooth projective variety over k . Fix an ample line bundle L on X . Below we only consider maps over k . We say that X is:

- (1) *Brody hyperbolic* if $k = \mathbb{C}$ and there is no non-constant holomorphic map $f : \mathbb{C} \rightarrow X$, where here we treat X as a complex manifold;

- (2) *algebraically hyperbolic* if there exists $a, b \in \mathbb{R}_{\geq 0}$ such that for every smooth curve C over k and a finite map $f : C \rightarrow X$ we have

$$\int_C c_1(f^*L) \leq a \cdot g(C) + b,$$

where $g(C)$ is the genus of C ;

- (3) *bounded* if, for every normal integral projective scheme Y over k , the scheme $\underline{\mathrm{Hom}}_k(Y, X)$ is of finite type over k (in particular it is definable in ACF_0 over k);
(4) *1-bounded* if, for every smooth projective curve C over k , the scheme $\underline{\mathrm{Hom}}_k(C, X)$ is of finite type over k ;
(5) *groupless* if, for any connected finite type group scheme G over k , there are no non-constant maps $G \rightarrow X$;
(6) *pure* (over k) if, for any smooth variety T over k , any rational map $T \dashrightarrow X$ extends to a regular map $T \rightarrow X$.

Remark 5.3. In fact the following implications hold:

$$(1) \implies (2) \implies (3) \iff (4) \implies (5) \implies (6),$$

where (1) \implies (2) only makes sense if $k = \mathbb{C}$. For the proofs of many of these implications, see [JK20]. Also, conditions (1) – (5) are conjectured to be equivalent, see [JK20, Section 9]. This is motivated by the case of curves, where (1) – (5) are equivalent to the genus of the curve being bigger or equal two. Note that an elliptic curve over k is pure, but not groupless.

Remark 5.4. Properties (2) – (6) are all geometric, in the sense that for any extension $k \subset l$ of algebraically closed fields, they hold for X over k if and only if they hold for X_l over l . For the proofs see [JK20, Theorem 1.5, Theorem 1.11] and the next remark.

Remark 5.5. It is worth to note that some of the above properties can be described differently (assuming notation from Definition 5.2), namely:

- X is pure if and only if every morphism $\mathbb{P}^1 \rightarrow X$ is constant;
- X is groupless if and only if for all abelian varieties A over k , all morphisms $A \rightarrow X$ are constant;
- X is bounded (or equivalently 1-bounded) if and only if there exist real numbers $\alpha(g)$ depending on X, L , such that for all smooth projective curves C over k and maps $f : C \rightarrow X$ we have

$$\int_C c_1(f^*L) \leq \alpha(g(C)),$$

where $g(C)$ is the genus of C .

For the proofs, see [JK20]. Also, let us remark that in [JK20, Definition 3.1] there is an additional condition on the rational map $T \dashrightarrow X$, namely that it is defined on an open subset $U \subset T$ with complement of codimension ≥ 2 . This assumption is redundant for projective X , for example by the curve-to-projective theorem from [Vak24, Exercise 17.5.B].

If the base-field is not necessarily algebraically closed, we use the following variant of pureness.

Definition 5.6. Let k_0 be any characteristic zero field (not necessarily algebraically closed). A projective variety \tilde{V} over k_0 is *geometrically pure*, if the base-change $\tilde{V}_{\bar{k}_0}$ is pure.

Geometric pureness is preserved under base-change in the following strong sense.

Proposition 5.7. [GLL14] *Let \tilde{V} be a geometrically pure, projective variety over a field k_0 . Let $k_0 \subset l$ be any field extension. Then \tilde{V}_l satisfies the definition of pureness over l , i.e., for any smooth variety T over l , any rational map $T \dashrightarrow \tilde{V}_l$ extends to a regular one.*

Proof. This is a direct consequence of [GLL14, Proposition 6.2] if we put $X = \tilde{V}_l \times_l T \rightarrow T = S$ in the notation there. \square

There exists a relative version of 1-boundedness which we present below.

Definition 5.8. Let $\Delta \subset X$ be a closed subscheme. We say that X is *1-bounded modulo Δ* , if for every smooth projective curve C over k , the scheme $\underline{\mathrm{Hom}}_k(C, X) \setminus \underline{\mathrm{Hom}}_k(C, \Delta)$ is of finite type over k . Similarly, we say that X is *bounded modulo Δ* , if for every normal projective variety Y over k , the scheme $\underline{\mathrm{Hom}}_k(Y, X) \setminus \underline{\mathrm{Hom}}_k(Y, \Delta)$ is of finite type over k .

In the case where k is not algebraically closed, we say that X is *geometrically bounded modulo Δ* if after base-change to the algebraic closure of k the corresponding pair satisfies the definition of being bounded modulo a subscheme.

In the non-relative setting these two notions are the same. In the relative setting this is only known under an additional assumption.

Lemma 5.9. [vBJK24, Lemma 9.9] *Assume that k is uncountable. Then X being 1-bounded modulo Δ implies that X is bounded modulo Δ .*

Moreover, similarly as in the non-relative case, it is true that boundedness modulo Δ implies existence of a uniform bound on degrees of curves mapped into X with the image not in Δ .

Theorem 5.10. [vBJK24, Theorem 1.26] *Let X be bounded modulo Δ and fix an ample line bundle L on X . Then there exist real numbers $\alpha(g)$ depending on X, Δ, L , such that for all smooth projective curves C over k of genus g and for all maps $f : C \rightarrow X$ with $f(C) \not\subset \Delta$ we have*

$$\int_C c_1(f^*L) \leq \alpha(g(C)).$$

Now we present a result that connects ampleness of the cotangent bundle to the rigidity conditions introduced above.

Theorem 5.11. (Kobayashi's theorem [Kob75], [Laz04b, Theorem 6.3.26]) *Assume that X is a smooth variety with an ample cotangent bundle Ω_X . Then X is algebraically hyperbolic. Moreover, if $k = \mathbb{C}$, then X is Brody hyperbolic.*

The other implication does not hold and one can conclude it for example from the following result originally proved by Kalka, Shiffman and Wong in [KSW81, Corollary 4] in the analytic setting.

Theorem 5.12. [Laz04b, Corollary 6.3.30] *Assume that X is a smooth variety with an ample cotangent bundle Ω_X . Let Y be an integral projective variety. Then the scheme $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(Y, X)$ is finite.*

So in particular, if C is a curve of genus greater than one, then $C \times C$ is algebraically hyperbolic (even Brody hyperbolic if $k = \mathbb{C}$), but does not have ample cotangent bundle. Indeed, note that for each $a \in C(k)$ there is a morphism $C \rightarrow C \times C$ given by $b \mapsto (b, a)$, hence the scheme $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(C, C \times C)$ is infinite.

Note that from Theorem 5.12 it follows that smooth varieties with ample cotangent line bundles are indecomposable. We also observe the following.

Lemma 5.13. *Assume that X is indecomposable. Then X is groupless.*

Proof. Assume for a contradiction that there is a non-constant map $A \rightarrow X$ from an abelian variety A over k . If we compose this map with addition $A \times_k A \rightarrow A$ we get a map

$$A \times_k A \rightarrow X$$

which does not factor through any projection to A . □

Remark 5.14. By the above lemma, an indecomposable variety is pure. Thus, in the definition of indecomposability we could equivalently impose, that all rational maps $X_1 \times X_2 \dashrightarrow X$ factor through X_1 or X_2 .

Motivated by the conjectural equivalence of conditions (1) – (5) from Definition 5.2 we ask the following.

Question 5.15. Assume that X is indecomposable. Is X bounded?

Note that this question has a positive answer in dimension one, where indecomposability and all other hyperbolicity properties are equivalent to having genus at least two. For some partial results in arbitrary dimension see [vBJK24].

A plenty of examples of smooth varieties with ample cotangent bundle is provided by the following theorem proved by Brotbek and Darondeau.

Theorem 5.16. [BD18, Theorem 0.1] *Let M be an N -dimensional smooth projective variety over k with a very ample line bundle $\mathcal{O}_M(1)$. Pick an integer $N/2 \leq c \leq N$ and $\delta \in (\mathbb{Z}_{>0})^c$. Then there exists $\nu(\delta) \in \mathbb{Q}$ such that for all multi-degrees $(d_1, \dots, d_c) = \nu \cdot (\delta_1, \dots, \delta_c)$ with $\nu \in \mathbb{Q}$ such that $\nu \geq \nu(\delta)$, the complete intersection of general hypersurfaces $H_1 \in |\mathcal{O}_M(d_1)|, \dots, H_c \in |\mathcal{O}_M(d_c)|$ has ample cotangent bundle.*

For some other examples of varieties with ample cotangent bundle, see [Laz04b, Section 6.3]. Let us also note that strong positivity assumptions on Ω_X can also yield finiteness results like the following.

Theorem 5.17. [Mor94] *Let X be a smooth variety over a number field k_0 such that Ω_X is ample and globally generated (i.e., the canonical map $H^0(X, \Omega_X) \otimes_{k_0} \mathcal{O}_X \rightarrow \Omega_X$ is surjective). Then $X(k_0)$ is finite.*

Moreover, Lang’s conjecture predicts that in the above theorem global generatedness is redundant, see [Mor94, Conjecture D]. The above result ultimately relies on the following theorem of Faltings.

Theorem 5.18. [Fal91] *Let X be a closed subvariety of an abelian variety A over k . Then there is a closed proper subscheme $Y \subset X$ such that X is Mordellic modulo Y , i.e., for any finitely generated field k_0 and any model X_0 for X over k_0 , the set $X_0(k_0) \setminus Y$ is finite.*

In particular, using this theorem we can get plenty of examples of varieties that we will later see to be excludable.

Corollary 5.19. *Let A be an abelian variety over k and let X be obtained by a sufficiently general intersection of ample line bundles as in Theorem 5.16. Then there is a finitely generated subfield $k_0 \subset k$, a k_0 -model X_0 of X and a closed proper subscheme $Y_0 \subset X_0$, such that $(X_0 \setminus Y_0)(k_0)$ is empty, and the cotangent bundle of X_0 is ample. Moreover, we can assume that X_0 is geometrically integral and smooth.*

6. MODEL COMPANION VIA HILBERT SCHEMES

In this section, we fix a characteristic zero field k_0 (not necessarily algebraically closed) and use the notation k for an extension of the field k_0 . Fix a geometrically integral projective variety \tilde{V} over k_0 . Let $V_0 \subset \tilde{V}$ be a closed proper subscheme such that \tilde{V} geometrically is bounded modulo V_0 and denote $V = \tilde{V} \setminus V_0$. Moreover, fix a smooth projective morphism between varieties $\mathcal{X} \rightarrow S$ over k_0 with geometrically integral fibers and with a closed subscheme $\mathcal{Z} \subset \mathcal{X}$. The below proposition is a variant of [Laz04b, Theorem 6.3.29] in families.

Proposition 6.1. *There is a quasi-projective morphism $H \rightarrow S$, such that for each $s \in S(k)$ the pullback H_s is isomorphic to $\underline{\mathrm{Hom}}_k^{\mathrm{nc}}(\mathcal{X}_s, \tilde{V}_k) \setminus \underline{\mathrm{Hom}}_k(\mathcal{X}_s, (V_0)_k)$.*

Proof. By Remark 4.7 and Remark 4.8 the scheme $\underline{\mathrm{Hom}}_S(\mathcal{X}, \tilde{V} \times_{k_0} S)$ has two closed subschemes $\underline{\mathrm{Hom}}_S^c(\mathcal{X}, \tilde{V} \times_{k_0} S)$ and $\underline{\mathrm{Hom}}_S(\mathcal{X}, V_0 \times_{k_0} S)$. Take H to be their complement, i.e., $H = \underline{\mathrm{Hom}}_S^{\mathrm{nc}}(\mathcal{X}, \tilde{V} \times_{k_0} S) \setminus \underline{\mathrm{Hom}}_S(\mathcal{X}, V_0 \times_{k_0} S)$. Note that fibers of H over points of S are as claimed, so it is enough to check quasi-projectivity over S .

Note that H is an open subscheme of $\underline{\mathrm{Hom}}_S(\mathcal{X}, \tilde{V} \times_{k_0} S)$ which furthermore is naturally an open subscheme of the Hilbert scheme

$$\underline{\mathrm{Hilb}}_S(\mathcal{X} \times_S (\tilde{V} \times_{k_0} S)) = \underline{\mathrm{Hilb}}_S(\mathcal{X} \times_{k_0} \tilde{V}).$$

If we fix a relatively ample line bundle on \mathcal{X} over S and an ample line bundle on \tilde{V} , this scheme can be written as a disjoint sum

$$\underline{\mathrm{Hilb}}_S(\mathcal{X} \times_{k_0} \tilde{V}) = \bigcup_P \underline{\mathrm{Hilb}}_S^P(\mathcal{X} \times_{k_0} \tilde{V}),$$

where P varies among Hilbert polynomials with respect to the relatively ample line bundle (over S) induced on $\mathcal{X} \times_{k_0} \tilde{V}$. Moreover, all $\underline{\mathrm{Hilb}}_S^P(\mathcal{X} \times_{k_0} \tilde{V})$ are projective over S , and by Remark 4.4 there are only finitely many Hilbert polynomials with fixed degree and bounded leading coefficient. Since all components $\underline{\mathrm{Hilb}}_S^P(\mathcal{X} \times_{k_0} \tilde{V})$ are projective over k_0 , to prove that H is quasi-projective, it is enough to show that for $k = k_0$, if

$$[f] = (f : \mathcal{X}_s \rightarrow \tilde{V}_k) \in H(k),$$

then there is a bound on the leading coefficient of P such that $[f] \in \underline{\mathrm{Hilb}}_k^P(\mathcal{X}_s \times_k \tilde{V}_k)$, and this bound is independent of f and of the image $s \in S(k)$ of $[f]$. Note that by Remark 4.3 (the last point) the degree of P such that $[f] \in \underline{\mathrm{Hilb}}_k^P(\mathcal{X}_s \times_k \tilde{V}_k)$ is fixed and equal to $\dim \mathcal{X}_s$, because the dimension of the graph of f is equal to the dimension of \mathcal{X}_s .

Fix $[f]$ and $s \in S(k)$ as above. Let \mathcal{L} be a relatively ample line bundle on \mathcal{X} over S and let L be an ample line bundle on \tilde{V} . Note that the degree of the Hilbert polynomial of $[f] \in \underline{\mathrm{Hilb}}_k^P(\mathcal{X}_s \times_k \tilde{V}_k)$ can be calculated as the following intersection number

$$\frac{1}{d!} \int_{\mathcal{X}_s} c_1(\mathcal{L}_s \otimes f^*(L_k))^d,$$

where d is the relative dimension of \mathcal{X} over S . By using the same reasoning as in [Laz04b, Proof of Theorem 6.3.29], if we can bound the number

$$\int_{\mathcal{X}_s} c_1(\mathcal{L}_s)^{d-1} c_1(f^*(L_k))$$

independently of s and $[f]$, then we will be done (one can also argue the sufficiency of such bound by the Khovanskii-Teissier inequalities, see Remark 3.6).

Now we use Bertini theorem to take sections t_i in $H^0(\mathcal{X}_s, \mathcal{L}_s)$ for $i = 1, \dots, d-1$ such that the zero sets of t_i 's form a complete intersection smooth curve $C \subset \mathcal{X}_s$ which is not mapped to $(V_0)_k$ by f (this curve depends on s and f). Let g be the genus of C . By Theorem 5.10 we get that there is a number $\alpha(g)$, such that

$$\int_{\mathcal{X}_s} c_1(\mathcal{L}_s)^{d-1} c_1(f^*(L_k)) = \int_C c_1(f^*(L_k)) \leq \alpha(g).$$

Let $e = \int_{\mathcal{X}_s} c_1(\mathcal{L}_s)^d$ and note that it is independent of s by flatness of the family \mathcal{X} over S . We can bound g using [GLP83] in the following way

$$g \leq e^2 - 2e + 1.$$

This yields the bound

$$\int_{\mathcal{X}_s} c_1(\mathcal{L}_s)^{d-1} c_1(f^*(L_k)) \leq \alpha(g) \leq \max_{g \leq e^2 - 2e + 1} \alpha(g),$$

which is independent of $[f]$ and s . This finishes the proof. \square

Remark 6.2. Note that the above proof actually shows that if the conclusion of Theorem 5.10 is satisfied for the base-change to the algebraic closure of the pair $V_0 \subset \tilde{V}$, then \tilde{V} is geometrically bounded modulo V_0 . Moreover, if in the above proof we assume that V_0 is empty and the fiber \mathcal{X}_s is fixed, then the curve C does not depend on f . Thus in that case the above proof recovers the implication “1-bounded implies bounded” from [JK20, Theorem 9.3].

Lemma 6.3. *Assume that \tilde{V} is geometrically pure. Let $H \rightarrow S$ be the quasi-projective morphism constructed in the above proposition. The following conditions on the field k are equivalent.*

- (1) *For any pair $Z \subset X/k$ appearing as a k fiber of $\mathcal{Z} \subset \mathcal{X} \rightarrow S$, either there is a non-constant rational map $f : X \dashrightarrow \tilde{V}_k$ over k not factoring through the inclusion $(V_0)_k \subset \tilde{V}_k$ or $(X \setminus Z)(k)$ is non-empty.*
- (2) *The following sentence is true:*

$$(\forall s \in S(k))(H_s(k) \neq \emptyset \vee (\mathcal{X} \setminus \mathcal{Z})_s(k) \neq \emptyset).$$

Proof. First, note that, by Proposition 5.7, it follows that \tilde{V}_k itself satisfies the extension principle from the definition of pureness. In particular, in (1) above we can only quantify over regular maps $f : X \rightarrow \tilde{V}_k$ over k . This finishes the proof of this lemma, by the characterisation of fibers of the scheme H from Proposition 6.1. \square

Corollary 6.4. *Let \tilde{V}_0 be a geometrically integral projective variety over k_0 and $V_0 \subset \tilde{V}$ be a closed proper subscheme such that \tilde{V} geometrically is bounded modulo V_0 . Let $V = \tilde{V} \setminus V_0$. Consider the property (II_V) for a field k , i.e.,*

(II_V) *For any geometrically integral variety X/k , either there is a non-constant rational map $f : X \dashrightarrow V$ over k or $X(k)$ is Zariski dense in X .*

This is an elementary property of the field k . More precisely, it is elementary in $L_{\text{rings}}(k_0)$, i.e., in the language of rings expanded with constant symbols for elements in k_0 .

Proof. This follows from Proposition 4.5 and Lemma 6.3. \square

Over all this proves the following statement.

Theorem 6.5. *Let \tilde{V} be a geometrically integral, geometrically pure, projective variety over k_0 . Let $V_0 \subset \tilde{V}$ be a closed subscheme such that \tilde{V} is geometrically bounded modulo V_0 . Let $V = \tilde{V} \setminus V_0$. Then V is excludable.*

Remark 6.6. In the above corollary one can skip the assumption that \tilde{V} is geometrically pure. This follows from the proof of Proposition 6.1 and the proof of existence of model companion for curve excluding fields in [JY23a] (using Chow schemes rather than Hilbert schemes). We leave this as an exercise to the reader.

Corollary 6.7. *Let $V_0 \subset \tilde{V}$ be a pair obtained as in Corollary 5.19 (with $V_0 = Y_0, \tilde{V} = X_0$). Then $V = \tilde{V} \setminus V_0$ is excludable.*

Remark 6.8. In general, if \tilde{V} is only assumed to be 1-bounded/bounded, it is unclear if the axiomatisation of VXF is computable. The computability of the set of the axioms of VXF relies on the computability of the function α from the data of X, L in Remark 5.5. If \tilde{V} is algebraically hyperbolic, then the axiomatisation above is indeed computable.

In some sense, one can use the complexity/computability of axiomatisation in VXF as a measurement of the hyperbolicity of V . However, there might not be any real examples fitting in between as suggested by the conjecture that groupless implies algebraically hyperbolic.

7. VXF FOR INDECOMPOSABLE V

Throughout this section, we fix a characteristic zero base-field k_0 and let V be a quasi-projective excludable variety over k_0 . Moreover (if not stated otherwise) assume that V has a projective compactification \tilde{V} which is geometrically integral and geometrically indecomposable. We study the properties of VXF for such V . Note that this is the case when \tilde{V} is X_0 from Corollary 5.19. We freely use Proposition 4.13 and Proposition 5.7 for base-changes of \tilde{V} . Slightly abusing notation, let VXF_{\forall} be the theory T_V of k_0 -fields that avoid V , which explicitly means that $V(K) = \emptyset$. We skip the proofs that follow exactly as the curve case in [JY23a].

Proposition 7.1. *Let V be an arbitrary excludable quasi-projective variety with a smooth projective completion \tilde{V} . If $k \models VXF$, then k is large if and only if $\tilde{V}(k) = \emptyset$.*

Lemma 7.2. *If k is a field and l_1, l_2 are two regular extensions satisfying VXF_{\forall} , then $\text{Frac}(l_1 \otimes_k l_2) \models VXF_{\forall}$.*

Proof. This is essentially a restatement of the geometrically indecomposability of \tilde{V} . We may assume that l_1 and l_2 are finitely generated over k , hence $l_i = k(X_i)$ for some geometrically integral, smooth (by resolution of singularities) X_i/k . Since l_i avoids V , there is no non-constant rational map $X_i \dashrightarrow V_k$ over k . Assume for a contradiction, that there is a rational map $f : X_1 \times_k X_2 \dashrightarrow V_k$ over k . Since \tilde{V} is geometrically pure, there is a regular extension $f : X_1 \times_k X_2 \rightarrow \tilde{V}_k$ over k . As \tilde{V} is geometrically indecomposable, f factors through the projection to X_1 or X_2 . This gives a contradiction. Hence $\text{Frac}(l_1 \otimes_k l_2) = k(X_1 \times X_2)$ avoids V . \square

The above lemma is the replacement for [JY23a, Lemma 4.3, 4.4], which enables us to generalise (without any changes) some results from the curve case in [JY23a] to VXF. For example, we immediately get the following.

Lemma 7.3. *Let k be a k_0 -field and l_1, l_2 be two regular extensions of k satisfying VXF. Then the identity map from k to k is partial elementary between the L_i 's. In other words, $l_1 \equiv_k l_2$.*

For the remainder of the statements, we list the generalisations here and point the readers to the proofs in [JY23a]. Let us recall the terminologies involved before stating the theorem.

For a field extension $k_0 \subset l$, recall that $\text{Abs}_{k_0}(l)$ for the field $l \cap \overline{k_0}$. Recall that an expansion of field $(K, +, \cdot, \dots)$ is *algebraically bounded over (a subfield) F* if for any formula $\varphi(\bar{x}, y)$, there are finitely many polynomials $P_1, \dots, P_m \in F[\bar{x}, y]$ such that for any \bar{a} , if $\varphi(\bar{a}, K)$ is finite, then $\varphi(\bar{a}, K)$ is contained in the zero set of $P_i(\bar{a}, y)$ for some i such that $P_i(\bar{a}, y)$ does not vanish. We say that K is *algebraically bounded* if it is algebraically bounded over K [vdD89]. By [JY23b], algebraically bounded over the prime field is the same as very slim in the sense of [JK10]. We say a field k is *Hilbertian* if there is $k \preceq k'$ and $t \in k' \setminus k$ such that $k(t)$ is relatively algebraically closed in K' . Lastly, recall that for a field k , its absolute Galois group $\text{Gal}(k)$ is ω -free¹, if for any surjective homomorphism of finite groups $\alpha : H \rightarrow G$ and any continuous surjective homomorphism $\beta : \text{Gal}(k) \rightarrow G$, there is a continuous surjective homomorphism $\gamma : \text{Gal}(k) \rightarrow H$ making the diagram commute:

$$\begin{array}{ccc} \text{Gal}(k) & \xrightarrow{\gamma} & H \\ & \searrow \beta & \downarrow \alpha \\ & & G. \end{array}$$

Proposition 7.4. *The theory VXF has the following properties.*

- (1) *Let $l_1, l_2 \models \text{VXF}$. Then $l_1 \equiv l_2$ if and only if $\text{Abs}_{k_0}(l_1) \simeq \text{Abs}_{k_0}(l_2)$ as k_0 -fields. Moreover, for any algebraic extension $k_0 \subset k$ avoiding V , there is a model $l \models \text{VXF}$ such that $\text{Abs}_{k_0}(l) = k$.*
- (2) *VXF has quantifier elimination if we expand by the predicates*

$$\text{Sol}_n(x_0, \dots, x_n) \leftrightarrow \exists y x_0 + yx_1 + \dots + y^n x_n = 0.$$
- (3) *Model-theoretic and field-theoretic (relative) algebraic closure coincide in models of VXF. In particular, models of VXF are algebraically bounded over k_0 .*
- (4) *VXF is a geometric theory, i.e., acl satisfies the exchange property and \exists^∞ is uniformly eliminated.*
- (5) *Every proper finite extension of models of VXF is a Hilbertian PAC field.*
- (6) *Models of VXF are Hilbertian. Moreover, the absolute Galois group is ω -free.*
- (7) *In the axiomatization of VXF one can in fact skip the axiom (I_V) . In other words, fields k that avoid V and satisfy (II_V) are models of VXF.*
- (8) *Model-theoretically, VXF is NSOP_4 and TP_2 .*

Proof. Essentially all of the proofs here follows from the proof of the analogue statement in [JY23a] replacing [JY23a, Lemma 4.5] with Lemma 7.3.

¹This definition is slightly different from the usual definition (for example in [FJ05]). Our definition is the first-order characterization of having ω -free Galois group in the classical sense.

The proof of (1) follows exactly the same as [JY23a, Theorem 4.6, 4.16], replacing the usage of Lemma 4.5 with Lemma 7.3.

For (2), it follows word for word as in the proof of [JY23a, Corollary 4.7].

For (3), it is [JY23a, Theorem 4.9].

(4) is the same as [JY23a, Corollary 4.12].

(5) and (6) are [JY23a, Theorem 4.23, 4.27] and [JY23a, Section 8].

(7) follows from (5).

(8) is the same as [JY23a, Corollary 4.28] and [JY23a, Theorem 6.7] relying on the fact that both VXF and ωPAC_0 admit quantifier elimination in the same language as in (2). \square

Lastly, we have the following description of the decidability of the incomplete theory VXF . The proof is the same as in [JY23a, Theorem 4.20] combined with Remark 6.8.

Proposition 7.5. *Let k_0 be a number field and \tilde{V} be algebraically hyperbolic over k_0 and V as before. Then the following two decision problems are Turing equivalent:*

- (1) *Given a sentence ϕ in the language of k_0 -algebras, determine whether $VXF \vdash \phi$.*
- (2) *Given a finite extension k/k_0 , determine whether $V(k) = \emptyset$.*

8. REMARKS AND QUESTIONS

We start by explaining some reasons why in general we cannot hope for the existence the model companion of fields excluding V in positive characteristic.

Let k_0 be a perfect characteristic p field properly containing the algebraic closure of a finite field. Let V be a genus two, smooth, geometrically integral, geometrically indecomposable, projective curve over k_0 , with $V(k_0) = \emptyset$, which is not defined over any finite field. In particular, we can form Frobenius twists of V which we denote by $V^{(p^n)}$ for $n \in \mathbb{Z}$. Note that all $V^{(p^n)}$'s are also genus two, smooth, geometrically integral, projective curves over k_0 as base-changes of such. Moreover, these Frobenius twists can be assumed to be pairwise non-isomorphic (even geometrically). Indeed, to ensure this we can pick V to be defined by the Weierstrass equation for genus two curves, outside countably many closed conditions on parameters defining V .

Lemma 8.1. *Assume that C is a genus two, smooth, geometrically integral, projective curve over a field k extending k_0 with a non-constant map to V_k over k . Then C is isomorphic to some negative Frobenius twist of V_k , possibly after passing to the algebraic closure of k .*

Proof. Fix a non-constant map $f : C \rightarrow V_k$ over k from the assumptions. By [Sta24, Proposition 0CD2] we can decompose it as $C \rightarrow C^{(p^n)} \rightarrow V_k$ for some natural n , where $C^{(p^n)} \rightarrow V_k$ induces a separable field extension.

Note that $C^{(p^n)}$ is also a genus two, smooth, geometrically integral, projective curve over a field k , by being a flat base-change of such. Hence, by the Riemann-Hurwitz theorem, as in [Sta24, Lemma 0C1D], the map $C^{(p^n)} \rightarrow V_k$ is an isomorphism.

By definition $C^{(p^n)}$ and V_k are base-changes via n 'th power of Frobenius of C and $V_k^{(p^{-n})}$ respectively. Passing to the algebraic closure of k , the Frobenius map becomes an automorphism of \bar{k} . Hence, we get that over \bar{k} the curve $C_{\bar{k}}$ is isomorphic to $V_{\bar{k}}^{(p^{-n})}$, which finishes the proof. \square

Proposition 8.2. *In the above context, the theory T_V does not admit a model companion.*

Proof. Assume for a contradiction that the model companion VXF exists. Let $\mathcal{C} \rightarrow S$ be the Weierstrass family of genus two smooth, geometrically integral, projective curves. Then each geometric isomorphism type of a fiber appears only finitely many times. For more details, see for example [Igu60].

Consider a model $k \models VXF$. Note that for $s \in S(k)$ the curve $C = \mathcal{C}_s$ can be in one of two groups:

- either C admits a non-constant map to V_k over k , in which case $C(k)$ is empty,
- or, C does not admit such a map, in which case $C(k)$ is infinite.

By geometric indecomposability of V , one could show that VXF eliminates \exists^∞ as in Theorem 7.4. Hence, the set of $s \in S(k)$ belonging to any of two groups above is definable.

We claim that the set $\{s \in S(k) : \mathcal{C}_s(k) = \emptyset\}$ is in fact countable, which will give a contradiction by compactness (since k is an arbitrary model of VXF). This follows from Lemma 8.1 and the fact that in $\mathcal{C} \rightarrow S$ each geometric isomorphism type of a fiber appears only finitely many times. \square

Next, we list some potential extensions and questions of immediate relevance.

- Question 8.3.** (1) The results presented in Section 7 are established for geometrically indecomposable varieties V . However, the model theory of VXF remains rather mysterious when V is decomposable. It is anticipated that VXF would exhibit more exotic behavior in this scenario.
- (2) In the proposition above, we give an example of a variety V in characteristic p , such that T_V does not admit a model companion. What about such examples in characteristic zero? Does excludability of V implies some form of “rigidity” of V ?
- (3) What are the concrete models of VXF ? For example, is there $k \models VXF$ such that $k \subset \overline{\mathbb{Q}}$? This seems hard and should be very much related to the notion of diophantine stability [MR18].
- (4) In the examples of VXF where we can determine the Galois group, the Galois group becomes ω -free, it might be worthwhile finding more examples along this line where the absolute Galois group becomes more interesting. One potential candidate is to look at fields avoiding V in the language where we expanded by a group action. As suggested by the machinery developed in [HK18], it is believable that the model companion in this setting exists as well.
